#### FEBRUARY 10, 2016

A special meeting of the Hope Township Committee convened at 5:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Deputy Mayor George Beatty, and Committeeman John Koonz. Also present were Municipal Clerk Mary Pat Quinn and Chief Financial Officer Kathleen Reinalda.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in The Express Times and by posting notice in the Hope Post Office and on the Township bulletin boards all on February 7, 2016.

#### Prepare 2016 Local Municipal Budget

Reinalda reviewed the balances in the Recreation Trust Fund Account and the Celebration of Public Events Trust Fund Account with the governing body. She explained that according to the instruction of the governing body and permission from the N.J. Division of Local Government Services, the Christmas Craft Market Trust Fund Account was changed to the Celebration of Public Events Trust Fund Account two years ago.

All of the revenue generated from the Christmas Craft Market, including the door admission and the money received from the crafters, continues to be deposited in this account. All of the expenses of the Christmas Market, including the Coordinator's salary are charged to the account. In addition, because there was a surplus in the account two years ago, the expenses for the annual family picnic, the Halloween Party, Christmas Tree lighting, the fishing derby, annual youth recognition, and the appreciation dinner are all charged to this account.

Reinalda expressed concern that the revenue taken in for the Christmas Craft Market this year will not support all of the expenses that are charged to the account. There was a discussion about how this situation can be improved. Preliminarily, \$30,000.00 was inserted in to the general operating budget in "Celebration of Public Events". Reinalda was asked to provide the governing body with detail on what was spent for each event in CY 2015.

The budget worksheet prepared by the Municipal Auditor was reviewed. In anticipation of hiring additional help for the Department of Public Works, the salary and wage line item was preliminarily increased by \$75,000.00. Beatty recommended that new full-time employees should receive health insurance for themselves; however, they would be required to pay the additional premium for family coverage if that applies. The Township is no longer using an outside contractor for cleaning services at the Community Center, Moravian Grange Hall and the Municipal Building. A paid employee will receive \$13.00 per hour with a maximum set at twenty hours per week. A new line item, Public Buildings and Grounds, Salaries and Wages was established in the budget.

The budget request from the Public Works Department was reviewed and discussed.

The meeting was adjourned at 6:10 P.M. on a motion made by Koonz, seconded by Beatty. The motion was carried.

The monthly business meeting of the Hope Township Committee convened at 7:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Deputy Mayor George Beatty, and Committeeman John Koonz. Also present were Municipal Clerk Mary Pat Quinn and Township Engineer Ted Rodman.

### TOWNSHIP ENGINEER'S REPORT

Rodman reported that the closeout paperwork for the Smith Street and Green Street overlayment project is nearly complete. He needs the Mayor to sign the State voucher for the final payment and the confirmation of expenses certification signed by the CFO.

A pre-construction meeting will be planned with Riverview Paving, Inc. for the catch basin repair/replacement project.

The salt shed repair/replacement project is still under advisement.

Rodman's office assisted with the FEMA application for a generator for the DPW garage.

Rodman left the meeting at this time.

Doug Tighe, a resident of Hope, asked how the policy will work. Beatty answered that a subcommittee will be formed to include him and the three sports directors. They will collectively review issues and make decisions together.

Koonz added that the suggested order of progression is to have the parents resolve potential issues between themselves while setting a good example. If this does not work, then the parent(s) are to discuss the issue with the respective coach. The coach, if there is no resolution, will bring the matter to the director for that sport. The director will ultimately bring the matter to the Township Committee if he/she cannot resolve it. He asked that people conduct themselves in a civilized manner, and that from time to time, people may have to agree to disagree.

Dan McGovern, a resident of Hope, expressed concern about children from outside the Township having more playing time than children in Hope. Kim Tighe, a resident of Hope and the Hope Baseball/Softball Director, and Robin Keggan, a resident of Hope and the Hope Basketball Director, addressed that concern by explaining the leagues' policies.

After the Township Committee updates the policy and procedures manual, it will be given to the three sports directors for their input. Beatty added that he will be attending the baseball/softball coaches meeting before the season starts.
