FEBRUARY 11, 2015

The monthly business meeting of the Hope Township Committee convened at 7:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Deputy Mayor George Beatty, and Committeeman John Koonz. Also present were Municipal Clerk Mary Pat Quinn and Township Engineer Ted Rodman.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in The Express Times and the Star Gazette and by posting notices on the Township bulletin boards and the Hope Township website all on January 14, 2015 and January 23, 2015.

PROCLAMATION - "GO ALL OUT", NATIONAL FUTURE FARMERS OF AMERICA

Two members of the Belvidere Chapter of Future Farmers of America were present to discuss their club with the governing body and to request that the Mayor enact a Proclamation commemorating February 21 to 28, 2015 as FFA Week. Melissa Strom, a resident of Hope Township and the Chapter Reporter was present with Maddie Beaumont, the Chapter Treasurer.

The following Proclamation was made by Mayor McDonough:

"GO ALL OUT" – NATIONAL FFA WEEK FEBRUARY 21-28, 2015

WHEREAS, FFA and agricultural education provide a strong foundation for the youth of America and the future of the food, fiber and natural resources systems; and

WHEREAS, FFA promotes premier leadership, personal growth and career success among its members; and

WHEREAS, agricultural education and FFA ensure a steady supply of young professionals to meet the growing needs in the science, business and technology of agriculture; and

WHEREAS, the FFA motto – "learning to do, doing to learn, earning to live, living to serve" – gives direction of purpose to these students who take an active role in succeeding in agricultural education; and

WHEREAS, FFA promotes citizenship, volunteerism, patriotism and cooperation.

THEREFORE, I, Timothy C. McDonough, Mayor of the Township of Hope in the County of Warren, New Jersey, hereby designate the week of February 21 to 28, 2015 as FFA Week.

McDonough advised that the Township Committee is pro agriculture. The Township has a very active, effective Agriculture Advisory Board.

BLAIRSTOWN AMBULANCE CORP BUDGET PRESENTATION

Present from the Blairstown Ambulance Corp were Paul McNamara, Treasurer, and Joe DiGrasia, President. McNamara advised that the Corp purchased a new ambulance costing \$201,000.00, and their new building is ready for occupancy. They are asking for an additional \$128.00 above last year's appropriation due to an increase in their budget from \$150,000.00 last year to \$200,000.00 this year. The Corp will raise 62% of their budget, and they ask the municipalities to cover 38%. DiGrasia did ask the governing body to consider an additional donation to get them in to the new building.

McNamara stated that their membership is stable; however, they always welcome new volunteers. He spoke favorably about their relationship with the Hope Volunteer Fire Department. Koonz thanked them for their cooperation as well.

McNamara asked the governing body to modify Resolution #15-12, which was approved at the reorganization meeting, by adding the services of North Warren Emergency Medical Services.

APPOINT BLAIRSTOWN AMBULANCE CORP AND NORTH WARREN EMERGENCY MEDICAL SERVICES AS THE PRIMARY AMBULANCE SERVICES FOR CY 2015

WHEREAS, the Township of Hope requires emergency services from time to time; and

WHEREAS, the Blairstown Ambulance Corp and North Warren Emergency Medical Services can effectively and efficiently provide emergency services for the Township of Hope;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Committee of the Township of Hope in the County of Warren, New Jersey, that the Blairstown Ambulance Corp and North Warren Emergency Medical Services are hereby appointed as the primary ambulance services for Hope Township for calendar year 2015;

BE IT FURTHER RESOLVED that the Municipal Clerk is hereby directed to provide a certified copy of this action to the Office of the Blairstown Ambulance Corp and North Warren Emergency Medical Services.

A summary of the ambulance calls in Hope Township and on Route 80 in Hope Township was provided.

McNamara, DiGrasia, Stromm and Beaumont left the meeting at this time.

RESOLUTION AUTHORIZING MEMBERSHIP IN A MUTUAL AID AND ASSISTANCE AGREEMENT WITH PARTICIPATING UNITS

WHEREAS, mutual aid and assistance agreements between municipalities, counties, law enforcement agencies, police, fire departments, EMS organizations and Fire Districts are permitted pursuant to N.J.S.A. 40A: 14-26 and 40A: 14-156.1; and

WHEREAS, the President, in Homeland Security Directive (HSPD-5), directed the Secretary of the Department of Homeland Security to develop and administer a National Incident Management System (NIMS), which would provide a consistent nationwide approach to Federal, State, local and tribal governments to work together more effectively and efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size or complexity; and

WHEREAS, "The New Jersey Civilian Defense and Disaster Control Act" App. N.J.S.A. 9-33 et. Seq, provides for the health, safety and welfare of the people of the State of New Jersey during any emergency by centralizing control of all civilian activities having to do with such emergency giving the Governor control over the resources of each and every political subdivision to cope with any condition that shall arise out of such emergency; and

WHEREAS, The Director of the Division of Fire Safety in the Department of Community Affairs promulgated rules in accordance with the "Fire Service Resource Emergency Deployment Act," N.J.A.C. 52: 14E-11 et. seq., commonly referred to as the "Fire Service Resource Emergency Deployment Regulations" N.J.A.C. 5:75A et. seq.; and

WHEREAS, it is deemed to be in the best interests of the residents of this municipality to enter into a mutual aid and assistance agreement with the County of Warren and other municipalities including but not limited to, municipal police, fire department and EMS organizations to provide additional protection against loss, damage or destruction by fire, catastrophe, civil unrest, major emergency or other extraordinary devastation damage or destruction to person and property, in those situations when outside aid and assistance is needed.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hope in the County of Warren, New Jersey as follows:

- A. That Township of Hope is hereby authorized and directed to enter into Warren County Mutual Aid and Assistance Agreement between Participating Units, a copy of which is attached hereto and made part hereof, on the terms and conditions contained herein.
- B. That the Mayor and Municipal Clerk of the Township of Hope are hereby authorized and directed to execute said Mutual Aid and Assistance Agreement on behalf of the Township of Hope
- C. That the Municipal Clerk is hereby authorized and directed to forthwith file a certified copy of this Resolution and an executed copy of the Agreement with the Warren County Department of Public Safety, Office of Emergency Management. Said Office shall serve as the central repository and shall maintain a master listing of all Participating Units to the Mutual Aid and Assistance Agreement.

RESOLUTION AUTHORIZING AN APPLICATION FOR THE 2014 RECYCLING TONNAGE GRANT

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L. 1987, c. 102, has established a recycling fund from which tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and

WHEREAS, the New Jersey Department of Environmental Protection has promulgated recycling regulations to implement the Mandatory Source Separation and Recycling Act; and

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and to indicate the assent of Hope Township Committee to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hope that Hope Township hereby endorses the submission of the recycling tonnage grant application to the New Jersey Department of Environmental Protection and designates Linda Gabel to ensure that the application is properly filed; and

BE IT FURTHER RESOLVED that the monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes of recycling.
