The Clerk will provide Klauder with a tax exempt letter for Dick's Sporting Goods, and \$800.00 has been approved from the Recreation Fundraising Account to cover the costs of the event.

The governing body thanked Klauder for organizing the Fishing Derby again this year. Klauder left the meeting at this time.

SECTION II. If any section, clause, sentence or other part of this Ordinance shall, for any reason, be adjudged by the Court of Competent Jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

SECTION III. All ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION IV. This Ordinance shall take effect and shall become operative twenty days after publication thereof, after final adoption; unless within said twenty (20) days a petition signed by voters of the Township equal in number to at least five (5) percent of the registered voters of the said Township of Hope, protesting against the adoption of this Ordinance be presented to the Hope Township Committee, in which case the provisions of Section I of this Ordinance, which provides for increased salaries, wages or compensations of the elected officials, shall remain inoperative unless and until a proposition for the ratification of such portions of this Ordinance shall be adopted at an election by a majority of the voters voting on said proposition.

<u>Concord Energy Services – Government Energy Aggregation</u>

Wendy Molner, Vice-President of Government Relations, Concord Energy Services, was present to discuss Government Energy Aggregation and how it will benefit Hope Township residents.

McDonough advised that he would be recusing himself from any action that the governing body may take due to a business relationship that he has with Concord Energy Services.

Molner explained that Community Energy Aggregation is a program that allows municipalities to negotiate the bulk purchase of energy supply on behalf of residents and local businesses at prices that are lower than the utility price to compare. There is no cost to Hope Township or the community to implement the program. She noted that some programs have saved up to 14% compared to the utility price. An Ordinance would be required to authorize Hope's participation in the program. Concord will work with Hope to provide a marketing and outreach program.

The governing body asked that Concord conduct a public information presentation prior to the public hearing on the Ordinance. The Clerk and Molner will work out a mutually convenient date.

Introduce Ordinance #16-05, Establish an Energy & Natural Gas Aggregation Program

ORDINANCE #16-05

AN ORDINANCE OF HOPE TOWNSHIP ESTABLISHING AN ENERGY AND NATURAL GAS AGGREGATION PROGRAM IN THE TOWNSHIP OF HOPE, COUNTY OF WARREN, NEW JERSEY

WHEREAS, the State of New Jersey has been engaged in a process to establish a competitive market place through deregulation and restructuring the electric utility market and natural gas market; and

WHEREAS, the establishment of a government aggregator and an energy aggregation program to purchase electric generation service and natural gas pursuant to N.J.S.A. 48:3-93.1 et seq. and N.J.A.C. 14:4-6.1 et seq. will increase competition for the provision of electric power and natural gas to residential and non-residential users, thereby increasing the likelihood of lower electric rates and natural gas rates for these users without causing any interruption in service; and

WHEREAS, under the aggregation process the residential and non-residential ratepayers may likely receive a direct reduction in their electric bills and gas bills; and

WHEREAS, the realization of energy costs savings is in the interests of the health, safety and welfare of the residents of Hope Township (the "Township"); and

WHEREAS, the Township hereby finds that it is in the best interests of residential and non-residential electric ratepayers for the Township to create the opportunity for them to enter into an aggregation agreement in order to seek substantial savings on electric rates; and

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hope in the County of Warren, New Jersey, duly assembled in public session, as follows:

- 1. The Township publicly declares its intent to become an aggregator of electric power on behalf of its residential and non-residential users of electricity pursuant to the Government Energy Act of 2003, N.J.S.A. 48:3-91.3 to -98, and implementing regulations.
- 2. The Township will utilize approved vendor Concord Engineering's d/b/a Concord Energy Services Reverse Energy Auction Platform pursuant to the NJ E-PROCUREMENT Pilot program (P.L. 2001, c. 30) under the NJ Department of Community Affairs. The Reverse Energy auction will seek bids from licensed and appropriate third party suppliers. If such winning bid is selected and agreement executed, individual residential consumers would retain the option not to participate and to choose any alternatives they desire, while non-residential ratepayers would also have the right to participate.
- 3. The Mayor and Township Clerk are hereby authorized and directed to execute any documents necessary to carry out the purpose of the Ordinance.
- 4. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- 5. If any portion of this ordinance shall be deemed invalid by any court of competent jurisdiction, the remainder shall survive in full force and effect.
- 6. This ordinance shall be effective immediately upon adoption and publication in accordance with law.

The public hearing will be on Wednesday, June 8, 2016 at 7:00 P.M.
