A RESOLUTION OF THE HOPE TOWNSHIP COMMITTEE APPOINTING A PROFESSIONAL PLANNER FOR THE PURPOSE OF PREPARING A REVISED HOUSING PLAN AND FAIR SHARE PLAN

WHEREAS, the Township Committee of the Township of Hope in the County of Warren, New Jersey has determined that the Hope Township Housing Plan and Fair Share Plan needs to be revised; and

WHEREAS, Heyer, Gruel and Associates with offices at 236 Broad Street, Red Bank, NJ 07701 has submitted an agreement dated May 6, 2015 for professional planning services not to exceed \$3,000.00, which the Township of Hope deems fair and equitable for said professional services; and

WHEREAS, the Local Public Contracts Law (N.J.S.A.40A:11-1,et seq.) requires that the Resolution authorizing the award of contracts for "Professional Services" without competitive bids and the contract itself must be available for public inspection; and

WHEREAS, Heyer, Gruel and Associates agree to incorporate into this contract the mandatory language pursuant to N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, as amended and supplemented from time to time and the contractor or subcontractor agrees to comply with the terms, provisions and obligations of said N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27; and

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Hope, of the County of Warren, as follows:

- 1. The Mayor and Clerk of the Township of Hope are hereby authorized and directed to execute a duplicate of this Resolution, which shall act as the authority and agreement between the Township of Hope and Heyer, Gruel and Associates retention as planners on and in behalf of the Township of Hope for the preparation of a revised Housing Plan and Fair Share Plan.
- 2. The services to be rendered by Heyer, Gruel and Associates as Planner shall be specifically for the services outlined in this action.
- 3. This contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A.40A:11-5(1)(a) of the Local Public Contracts Law because Heyer, Gruel and Associates is a licensed profession planning firm of the State of New Jersey and as such is duly qualified as a professional to carry out the subject services, which are expressly exempt from the Local Public Contracts bidding requirements.
- 4. A notice of this action shall be printed once the "The Star Gazette".
- 5. Copies of this resolution shall be forwarded to Heyer, Gruel and Associates, the Township Clerk and Chief Financial Officer.

Ms. Grace Lynch on September 4, 2013. The Clerk was directed to answer the current letter by sending a copy of the Township Attorney's letter.

ANIMAL CONTROL

The Animal Control Officer asked the governing body to consider adopting an Ordinance to address livestock running at large. He provided an ordinance from the Township of Hampton for consideration. The matter is under advisement.
