The monthly business meeting of the Hope Township Committee convened at 7:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Deputy Mayor George Beatty, and Committeeman John Koonz. Also present were Municipal Clerk Mary Pat Quinn and Township Engineer Ted Rodman.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in the Express Times and the Star Gazette and by posting notices in the Hope Post Office and on the Township bulletin boards all on January 14, 2015 and January 23, 2015.

APPROVAL OF MINUTES

The minutes of the special meeting and executive session on April 27, 2015 and the business meeting on May 13, 2015 were approved as circulated on a motion made by Koonz, seconded by Beatty. Committee polled: Beatty-yes; Koonz-yes; McDonough-yes. McDonough left the meeting room briefly.

The minutes of the work meeting on May 27, 2015 were tabled to the next business meeting. McDonough was not present to vote on them, and Koonz was absent from that meeting and would not be eligible to vote on the minutes.

RECEIPTS

The receipts during May, 2015 were read by Koonz, who noted those amounts over \$100.00. The total receipts were \$29,979.18.

BILLS

The bill list was read by Beatty, who also noted those amounts over \$100.00. A motion was made by Koonz, seconded by Beatty authorizing the payment of the bills totaling \$340,238.99. Committee polled: Beatty-yes; Koonz-yes; McDonough-absent.

REPORTS

The Clerk was away on vacation, and did not have time before the meeting to look through her mail; therefore, only the report from the Construction Official was available at the meeting.

Construction Code Official

The following permits were issued during May, 2015: 10 – Building, 5 – Plumbing, 5 – Electrical, 5 – Fire for a total income of \$3,474.00.

Township Engineer

Rodman reported that the crossbars were painted on Honey Run Road. He can close out the grant now.

Don Whitmore, the DPW Foreman, was present to review the specification for the salt shed with the governing body and the Township Engineer. The specifications were finalized, and Rodman will prepare a Notice to Bidders. The Clerk will place the notice in The Express Times; bids will be opened at the next business meeting on Wednesday, July 8, 2015 at 7:00 P.M.

There was a discussion about the drainage concern of Mr. and Mrs. Rennspies on Union Brick Road. Whitmore inspected the area during the last heavy rain and took photographs of the water flow. The water is coming from 102 Union Brick Road in Blairstown and following the gutter down to the Hope side of the road. Koonz asked if the situation is causing any traffic or safety problem, and Whitmore responded that it is not. The Township Committee directed Rodman to write a letter to Mr. and Mrs. Rennspies to refer them to Blairstown Township for a solution to their issue.

Beatty advised that there are five catch basins that need to be replaced by an outside contractor due to depth. Three quotations were sought, and All Terrain Excavating is the lowest responsible quote at \$3,200.00 each. A motion was made by Koonz, seconded by Beatty to authorize \$16,000.00 for the replacement of five catch basins by All Terrain Excavating. Committee polled: Beatty-yes; Koonz-yes; McDonough-absent.

Beatty also discussed the floor replacement in the bottom of the Community Center. The Committee determined that a concrete floor would be more appropriate in the basement. He will get a few quotations for that work, which will be done with funding from FEMA.

Mayor McDonough

McDonough advised that he received a letter dated June 5, 2015 from Richard Keiling, Esq., who is representing the Singh application before the Hope Zoning Board of Adjustment. Keiling asked the Mayor to appoint two additional members to the Board as the current membership of the Board is only 6 people. The applicant will need five affirmative votes for a "D" Variance.

The matter was discussed with the Zoning Board of Adjustment/ Planning Board Attorney, Roger Thomas, who indicated that the Township Committee would only need to appoint one new member. There are vacancies for Alternate #1 and #2. The new member could be appointed from the membership of the Hope Planning Board. With that said, McDonough reached out to the Planning Board Chairman, Marvin Fish, who suggested Steven Larena as the new member. Larena is available to fill that vacancy. McDonough left the room at this time to take a phone call.

A motion was made by Koonz, seconded by Beatty to appoint Steven Larena as a full member with a term expiring December 31, 2018. Committee polled: Beatty-yes; Koonz-yes; McDonoughabsent.

Deputy Mayor Beatty

Beatty reported that the Annual Fishing Derby has been rescheduled due to inclimate weather. The new date is Saturday, June 20, 2015 from 12:00 Noon to 4:00 P.M.

Committeeman Koonz

Koonz referred to the correspondence from Christopher and Meghan Smith of 343 High Street concerning the disturbance to the residents in the village area by the outdoor weddings at the Inn at Millrace Pond. In Smith's letter, he refers to a Hope Township Ordinance #20-4.6(a) that prohibits businesses from having outdoor sound producing devices. Koonz suggested that the Township follow up on this matter since it is becoming more a nuisance. McDonough asked the Clerk for a copy of the Ordinance, which he will deliver to the N.J. State Police – Hope Barracks.

Present from the Environmental Commission were Cathie LaBar, Patty Maertens, and Monica Sobon. McDonough returned to the meeting at this time.

LaBar distributed information that addressed the questions of the governing body from the last meeting. On the handout, the shale information was discussed at length. Koonz noted that he would like the governing body to read as much information as possible before considering a resolution or an ordinance. The remaining question is whether the geology in New Jersey can support fracking.

Sobon, LaBar, Maertens left the meeting at this time.

Status of Hope Sanitary Landfill

No change in status.

SECTION II. If any section, clause, sentence or other part of this Ordinance shall, for any reason, be adjudged by the Court of Competent Jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

SECTION III. All ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION IV. This Ordinance shall take effect and shall become operative twenty days after publication thereof, after final adoption; unless within said twenty (20) days a petition signed by voters of the Township equal in number to at least five (5) percent of the registered voters of the said Township of Hope, protesting against the adoption of this Ordinance be presented to the Hope Township Committee, in which case the provisions of Section I of this Ordinance, which provides for increased salaries, wages or compensations of the elected officials, shall remain inoperative unless and until a proposition for the ratification of such portions of this Ordinance shall be adopted at an election by a majority of the voters voting on said proposition.

Resolution #15-35, Approve 2014 Audit Report

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34; and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

GENERAL COMMENTS RECOMMENDATIONS

And

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

GENERAL COMMENTS RECOMMENDATIONS

As evidenced by the group affidavit form of the governing body; and

WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52-to wit:

R.S. 52:27BB-52 — "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director of the Local Government Services, under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE, BE IT RESOLVED, that the governing body of the Township of Hope hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

NOW, THEREFORE, BE IT RESOLVED that the following distribution of those funds is hereby designated:

Beatty reported that specifications are being prepared for a new truck. Koonz asked Whitmore if he reached out to the company that refurbishes trucks to see if this might be a good idea for the Township. Whitmore was not given the contact information as of the meeting but will follow up on it.

PUBLIC

Chris Rusin, a resident of Hope, asked about the non-household animal ordinance. Koonz explained that there have been situations where an abundance of non-household animals have been kept on small residential properties, which caused a nuisance to neighbors. The conditions were also difficult for the animals.

The meeting was adjourned at 8:15 P.M. on a motion made by Koonz, seconded by Beatty. The motion was carried.
