458 Delaware Road – Bread used for feed attracting rats and birds. Complainant affected is to call when the nuisance is occurring. No calls were received in May. The Municipal Clerk tried to arrange a joint inspection, but this department was unavailable.

Route 521 (exit 12 from Rt. 80) – Solid waste trucks going through Hope. File closed.

Inn at Millrace Pond – Noise from music during events at the Inn. Noise measurements were taken. None exceeded the noise code limit of 65 dBA. The complainant was advised and will call when the DJ's playing is louder.

551 Hope-Blairstown Road — NJDEP referred a complaint concerning two structures falling into wetlands and a 55-gallon drum leaking hydraulic oil onto the ground into a stream and two silos buried where they previously stood. An inspection was conducted. One drum appeared to have had a leak, which was staining soil but not entering any stream. It was reported that silos had been taken down two years ago but they were not buried as alleged. The person onsite was directed to clean up the contaminated soil. A reinspection was conducted. No evidence that the silos were buried was evident. There was a structure that had collapsed into the stream. After several inspections, the contaminated soil had been removed, but the collapsed structure was still in Beaver Brook. The property owner was advised in writing that the structure had to be removed. He agreed to address the issue. A reinspection is scheduled.

Land of Make Believe, Hope-Great Meadows Road – A complaint was received concerning a man without gloves or a hairnet touching food. Another complaint was received concerning a man and woman tasting fries and chicken while helping out at the food stand. The owner was contacted and advised of the complaints. Food safety requirements of not touching ready-to-eat food with bare hands and not eating in a food prep area were reviewed. The facility will be inspected when it is fully open for the season. File closed.

Food Establishment: St. John the Baptist Facility was inspected and received a satisfactory rating. Inn at Millrace Pond was inspected and received a conditionally satisfactory rating.

There was no activity for rabies, kennels, childcare centers, recreational bathing, youth camps, or septics/wells.

551 Hope-Blairstown Road – Collapsed structure in Beaver Brook. A reinspection was conducted. The structure had not been removed. When contacted, the responsible party reported that a firm had been hired, but work had not started yet. A reinspection is scheduled.

Food Establishment: St. John's United Methodist Church and Food Pantry, Swayze Mill Park Fieldhouse and Westbrooke Park Fieldhouse were inspected and received satisfactory ratings.

Kennels: Hope Kennels was inspected in March and received a satisfactory rating.

There was no activity for rabies, childcare centers, recreational bathing, or youth camps.

There was some discussion about 458 Delaware Road. The Zoning Officer will be asked to continue monitoring that situation.

Township Engineer

Rodman reported that the shoulder work needs to be completed on Honey Run Road; the Hope DPW will do that work.

FEMA asked for a revised site drawing for the proposed generator at the Moravian Grange. Rodman prepared that, and the Clerk forwarded it to the FEMA representative.

The Township will receive funding from NJDOT to overlay Smith and Green Streets. Rodman will get on Tilcon's list; Tilcon is the contractor approved by the Morris County Cooperative Pricing Council this year. In the meantime, the DPW will replace an old pipe on Smith Street.

McDonough advised that the pedestrian paracade sign that was located in front of the Hope Post Office has disappeared again. He asked Rodman to speak with the Warren County Engineer's Office about the possibility of putting up pedestrian crossing signs on the sides of the road as an alternative.

ORDINANCE #15-06

AN ORDINANCE TO AMEND CHAPTER 20-3, ENTITLED ZONING, OF THE REVISED GENERAL ORDINANCES
OF THE TOWNSHIP OF HOPE IN THE COUNTY OF WARREN, NEW JERSEY

WHEREAS, the Township Committee of the Township of Hope in the County of Warren, New Jersey, finds it necessary to clarify the keeping of Non-Household Animals" on residential land; and

WHEREAS, the Hope Township Committee in consultation with the Hope Township Planning Board has determined that the Hope Township Zoning Ordinance, Chapter 20-3 shall be revised to include definitions that will address this matter;

BE IT ORDAINED, by the Hope Township Committee that the following definitions shall be inserted in Chapter 20-3, Zoning, Definitions:

Non-Household Animal - The term "common household pet" means a domesticated animal, such as a dog, cat, bird, rodent (including a rabbit), fish or turtle that is traditionally kept in the home for pleasure rather than for commercial purposes. Pet animal includes dogs and cats kept for working purposes on a farm. If this definition conflicts with any applicable State or local laws or regulations defining the pets that may be owned or kept in dwelling accommodations, the State or local laws or regulations must be applied.

Residential Agriculture – The growing and harvesting of plant life and the keeping of non-household animals for the enjoyment of the residents on the property and not for commercial purposes, provided the following:

- A. A lot of at least two acres in size is required for the keeping of one non-household animal; and
- B. One additional acre of land is required for each additional non-household animal up to three (3) in total; and
- C. One-half additional acre of land is required for each additional non-household animal thereafter.

Nothing in this Zoning Ordinance shall be construed to apply to any commercial farming or agricultural use qualifying for a farmland assessment. All commercial farms or agricultural lands qualifying for a farmland assessment shall be permitted to maintain and raise pastoral animals without limitation, subject, however, to all applicable local and State statutes, ordinances, rules and regulations.
