BE IT RESOLVED, that Hope Township hereby recommends to the New Jersey Department of Transportation that the contract for the Far View Road Overlayment Project in the Township of Hope, County of Warren, New Jersey be awarded through the Morris County Cooperative Pricing Council

(MCCPC), to: Schifano Paving in the amount of \$75,940.00 and Denville Line Striping in the amount of \$4,060.00 subject to the approval of the Department.

BE IT FURTHER RESOLVED, that the presiding officer of this body be and is hereby directed to sign for and on its behalf the contract in the prescribed form for said construction; and the Clerk of this body be and is hereby directed to seal said contract with the corporate seal of this body and attest to the same.

Discuss DPW Salt Shed Repair/Replacement

There was a discussion about how the damaged salt shed should be dealt with. It was determined that the best approach would be to have the Township Engineer prepare specifications for a pole building. An estimate from JWL Contracting, Inc. of Schuylkill Haven, PA will be used as a starting point.

Use of Facility Request from Boy Scout Troop #146

Boy Scout Troop #146 requested the use of the remote camping area at Swayze Mill Park for the period September 26 to 28, 2014, 5:00 P.M. on Friday to Noon on Sunday. The written request was accompanied by the appropriate Certificate of Liability Insurance naming Hope Township as additional insured. A motion was made by Koonz, seconded by Beatty to approve the request. Committee polled: Beatty-yes; Koonz-yes; McDonough-yes.

Status of Municipal Court

The Chief Financial Officer advised the governing body that through July, the revenues for the court are only \$66,744.00; \$187,175.00 was anticipated in the budget. The Clerk was directed to ask the Judge to provide the amount of their accounts receivables as well as a projection through the end of 2014 of their anticipated caseload. The matter will be discussed at the business meeting on October 8, 2014.

McDonough advised that the Emergency Management subcommittee met earlier and determined that the Grange would be a suitable alternate location for a shelter.
