#### APPROVAL OF MINUTES

The minutes of the business meeting on July 5, 2016; the executive session on July 5, 2016; the business meeting on July 13, 2016; and the executive session on July 13, 2016 were approved as circulated on a motion made by Koonz, seconded by Beatty. Committee polled: Beatty-yes; Koonz-yes; McDonough-yes.

### **PRESENTATION**

William Eppel, Warren County Prosecutor's Office presented a program called GXP, Geospatial Exploitation Product or Critical Response Program. Handouts were provided for the audience. Mr. Eppel did a slide show presentation in which the program redefined requirement to efficiently plan, communicate, operate and report. The cost of the GXP program is about \$55,000. During the presentation, Mr. Eppel noted that all of the Warren County Municipalities are interested and in turn they are being asking to contribute a one-time fee of \$1200 to \$1500. The schools were also shown this program and very interested. They would be willing to contributing toward the yearly maintenance which is about \$15,000. The County is hopefully looking to have this in place by October.

## Township Engineer's Report

Mr. Rodman reported that the letter requested by the Warren County Health Department for the septic alteration on Hickory Road was been notarized by the Clerk and sent in.

Correspondence from FEMA for the DPW generator was received and there was some confusion. FEMA is requesting additional information on this project. Their request is for a detailed breakdown of the budget for the generator and attached to this email was a printout. Sarah and Judy are both working together on this. An update will be at the next meeting.

Gretta Sappha is looking for information on King Street. The Committee noted that these are all paper streets and once owned by the Smith Estate. It is suggested that she contact the Smith family.

A letter was sent to the State regarding the ramp at Exit 12 West Bound off of Route 80. So far there has been no response. The Mayor reported that a team from the State will be coming to look at this site as the Township is asking that the "Yield" sign be changed to a "Stop" sign.

The plans for the Salt Shed are moving forward. There are still many questions, but first what is needed are the drawings in order to go out to bid. The question is still bid vs. quote. Rodman pointed out again, that if the Township has a QPA, the bid threshold is \$40,000, without one; then it drops to \$17,500. Kathleen Reinalda, CFO for the Township, is also a Qualified Purchasing Agent (QPA) and if asked, would be interested in the position. The Committee was reminded that they would need to create the position by ordinance since it is not in the Code Book and then set the salary. The Clerk will ask Kathleen if she could come to their next meeting to discuss the possible position.

The Mayor discussed the possible donation of concrete/stone block that could be used for the salt shed. The only issued that came up was the cost for trucking them to the Township.

Rodman left the meeting at this time.

# AN ORDINANCE OF HOPE TOWNSHIP ESTABLISHING AN ENERGY AND NATURAL GAS AGGREGATION PROGRAM IN THE TOWNSHIP OF HOPE, COUNTY OF WARREN, NEW JERSEY

WHEREAS, the State of New Jersey has been engaged in a process to establish a competitive market place through deregulation and restructuring the electric utility market and natural gas market; and

WHEREAS, the establishment of a government aggregator and an energy aggregation program to purchase electric generation service and natural gas pursuant to N.J.S.A. 48:3-93.1 et seq. and N.J.A.C. 14:4-6.1 et seq. will increase competition for the provision of electric power and natural gas to residential and non-residential users, thereby increasing the likelihood of lower electric rates and natural gas rates for these users without causing any interruption in service; and

WHEREAS, under the aggregation process the residential and non-residential ratepayers may likely receive a direct reduction in their electric bills and gas bills; and

WHEREAS, the realization of energy costs savings is in the interests of the health, safety and welfare of the residents of Hope Township (the "Township"); and

WHEREAS, the Township hereby finds that it is in the best interests of residential and non-residential electric ratepayers for the Township to create the opportunity for them to enter into an aggregation agreement in order to seek substantial savings on electric rates; and

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hope in the County of Warren, New Jersey, duly assembled in public session, as follows:

- 1. The Township publicly declares its intent to become an aggregator of electric power on behalf of its residential and non-residential users of electricity pursuant to the Government Energy Act of 2003, N.J.S.A. 48:3-91.3 to -98, and implementing regulations.
- 2. The Township will utilize approved vendor Concord Engineering's d/b/a Concord Energy Services Reverse Energy Auction Platform pursuant to the NJ E-PROCUREMENT Pilot program (P.L. 2001, c. 30) under the NJ Department of Community Affairs. The Reverse Energy auction will seek bids from licensed and appropriate third party suppliers. If such winning bid is selected and agreement executed, individual residential consumers would retain the option not to participate and to choose any alternatives they desire, while non-residential ratepayers would also have the right to participate.
- 3. The Mayor and Township Clerk are hereby authorized and directed to execute any documents necessary to carry out the purpose of the Ordinance.
- 4. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- 5. If any portion of this ordinance shall be deemed invalid by any court of competent jurisdiction, the remainder shall survive in full force and effect.

6. This ordinance shall be effective immediately upon adoption and publication in accordance with law.
