AUGUST 14, 2019 BUSINESS MEETING

The work meeting of the Hope Township Committee convened at 7:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Deputy Mayor Christopher John Kruk and Committeeman Terry Urfer, Don Whitmore and Ted Rodman. Also present were Municipal Clerk, Judith Fisher, RMC, and Deputy Clerk Robin Keggan.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in The Star Gazette and The New Jersey Herald and by posting notices in the Hope Post Office and on the Township bulletin boards.

Reports:

Mayor Tim McDonough: None.

<u>Deputy Mayor Christopher John Kruk:</u>. Mr. Kruk read the update notice from the Sussex Warren Energy Co-op and explained to the residents present what the difference in rates between IDT and JCP&L meant.

<u>Committeeman Urfer</u>: Made mention of the house that the Township owns on Cedar Street that needs to demolitioned and needing to come up with a plan to do so for next year.

The blower and mason dump that were approved in the budget have already gone up in price. Mr. Kruk will look into obtaining a lower price on the blower than was received by Mr. Whitmore.

Mr. Urfer made mention of wanting to use some of the left over funding from the North Locust Lake paving project to tar and chip Lake Just-It (a cost of approximately \$2500. North Locust Lake will cost approximately \$5000 and there was \$15000 set aside for the project all together).

An engine braking sign will be placed at the top of Jenny Jump mountain.

Ovens are ready to be installed at the Grange.

North Locust Lake will be paved by end of August and Turpin Road will be paved by September 18.

<u>Township Engineer Report</u>: Mr. Rodman spoke about the Cemetery Road resurfacing project. Was due to start on August 19, 2019 but due to weather issues the schedule has been pushed back. He will advise Mr. Whitmore of the new date as soon as he receives it from the contractor so that notice can be made to residents living on that road.

Verizon Cell Tower update was given. A pre-construction meeting is needed (date t/b/d). All other items have been met for approval.

Septic System (Blair Street): new septic needs to be installed on property. Need a notarized document from the property owner adjoining giving permission to encroach for installation of the septic. Mr. Urfer suggested a Quit Claim Deed from the Township giving up any rights we MAY have may help the homeowner out in getting his system installed.

Union Brick Road: Mr. Urfer, Mr. Whitmore and Mr. Rodman have paid visits to the site to ascertain the issue. Mr. Urfer suggested putting a swale down both sides of the road (which would entail Mr. Ayers' neighbor moving his fence out of the right-of-way) and asked Mr. Ayers to please get a copy of his deed and/or survey to him so that they can determine the right-of-way. Title work will need to be ordered through the Township attorney as well. Don will cold patch any potholes on the road in the next two weeks.

SECTION III. All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency, only.

SECTION IV. This Ordinance shall take effect and shall become operative twenty (20) days after publication thereof, after final adoption; unless within said twenty (20) days a petition signed by voters of the Township equal in number to at least five (5) percent of the registered voters of said Hope Township, protesting against the adoption of this Ordinance be presented to the Hope Township Committee, in which case the provisions of Section I of this Ordinance, which provides for increased salaries, wages or compensations of the elected officials, shall remain inoperative unless and until a proposition for the ratification of such portions of this Ordinance shall be adopted at an election by a majority of voters voting on said proposition.

ORDINANCE 2019-07: Public Hearing and Adoption:

2019-07 AN ORDINANCE OF THE TOWNSHIP OF HOPE, COUNTY OF WARREN, STATE OF NEW JERSEY, AMENDING THE HOPE TOWNSHIP MUNICIPAL CODE, SECTION 2-1.9A ENTITLED "TAX LIENS ON FIRE DAMAGED PROPERTIES"

WHEREAS, New Jersey statutes permit municipalities to enact an ordinance preventing insurance companies from issuing payment on claims in excess of certain dollar amounts unless certain requirements have been met; and

WHEREAS, the Hope Township Committee enacted such an ordinance in 1995 pursuant to N.J.S.A. 17:36-9; and

WHEREAS, the Hope Township Committee now believes that is in the best interest of the Township to amend the subject ordinance so that it is consistent with certain changes in the law.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Hope, Warren County, New Jersey, as follows:

Section 1

The title to Chapter 2-1.9A of the Hope Township Municipal Code entitled "Tax Liens on Fire Damaged Properties" be amended to read as follows:

"Fire Insurance Claims"

Section 2

Chapter 2-1.9A of the Municipal Code of the Township of Hope is hereby amended to read as follows:

- § **2-1.9A(a)** Purpose. Pursuant to N.J.S.A. 17:36-9, the Township may, by ordinance, prohibit the payment to a claimant by an insurance company on any claim in excess of \$2,500 for fire damages on any real property located within the municipality prior to satisfaction of certain statutory requirements.
- **§ 2-1.9A(b)** Payment of Fire Insurance Claims Restricted. No insurance company authorized to issue fire insurance policies in the State of New Jersey shall pay an insured any claim in excess of \$2,500 for fire damages on any real property located within the municipality prior to satisfaction of certain statutory requirements.
- (1) All taxes and assessments and all other municipal liens or charges due and payable appearing on an official "certificate of search for municipal liens" pursuant to *N.J.S.A.* 54:5-12, shall have been paid either by the owner of such real property or by the insurance company; or
- (2) The Township submits to the insurance company a copy of a resolution adopted pursuant to N.J.S.A. 17:36-11 (installment payments), provided that if an appeal is taken on the amount of any lien or charge, other than an appeal on the assessed valuation of real property, pursuant to *N.J.S.A.* 54:3-21, the insurance company shall withhold 75 percent of the full amount of the lien or charge being contested pending termination of all proceedings.
- § 2-1.9A(c) Agreement with Owner; Restoration of Property. The Township Committee may, by resolution, enter into an agreement with the owner of any fire damaged property situated in the Township to pay in full all delinquent taxes, assessments or other municipal liens by installments, pursuant to *N.J.S.A.* 54:5-19, or for the redemption of a tax sale lien by installments, pursuant to *N.J.S.A.* 54:5-7, if the Township Committee is satisfied that the claim for fire damages is to be used to restore or improve the fire damaged property.

In the event of such resolution, a certified copy of the resolution shall be sent to the insurance company authorizing the insurance company to make full payment on the claim to the insured.

§ 2-1.9A(d) Mortgagee as Named Insured. Notwithstanding the provision of this Section, an insurance company may pay proceeds of a fire insurance policy to a mortgagee of a fire damaged real property where the fire insurance policy, at the time of the loss, listed the mortgagee as a named insured; provided the payment may not be in an amount which exceeds that due and payable to the mortgagee under the mortgage contract.

Section 3

This ordinance shall take effect immediately after passage.

Section 4

All ordinances or parts of ordinances of the Township of Hope inconsistent herewith are repealed to the extent of such inconsistency

Section 5

The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged to be unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

2019-45 RECOGNIZING THE NEGATIVE EFFECTS OF ANY LARGE PROPOSED DEVELOPMENT ON THE 22 MUNICIPALITIES OF WARREN COUNTY, NEW JERSEY

WHEREAS, the County of Warren, all 22 Municipalities, its Citizens and Institutions will be directly and indirectly affected by a 6 million square foot Warehouse and "to prove this, let facts be submitted to a candid World"

WHEREAS, Hope Township is one of 22 Municipalities in Warren County

WHEREAS, Hope was the first planned Community in New Jersey

WHEREAS, Hope was planned and built by Moravians, a Christian Denomination in 1760

WHEREAS, Hope Geographically a hub of 7 roads, was once considered for the location of the County seat

WHEREAS, Hope is currently a Community of 1900 people within 20 square miles

WHEREAS, Hope is a Community of diverse commerce: Banking, Real-estate, Amusement Park, Farming, Motorcycle Dealership, Antiques, Accountants, Insurance brokers, Gas station, Wedding venue, Farmers market, Volunteer Fire Department, State Park

WHEREAS, a Conceptual plan has been proposed for a 6 million square foot of warehousing in White Township

WHEREAS, the Professional estimate of Truck traffic would produce many thousands of trucks a day

WHEREAS, current Truck traffic is creating Kinetic energy producing mini-earthquakes destroying the foundations and structures of buildings within the Historic Village of Hope

WHEREAS, Hope Township lies in the direct path between Interstate 80 and the proposed Warehouses

WHEREAS, Warren County Planning Department's 2018 Transportation Technical Study, page 70 cites: CR 519 Intersection with US 46 White Township approaching capacity, US 46 pavement deficient, NJRTM-E US 46 approaching capacity, CR 519 approaching capacity

WHEREAS, WCTTS page 68 cites: Interstate 80, Interstate 78 and US 22 as some of the most heavily congested roadway segments in Warren County

WHEREAS, the unintended consequences of the warehouse development project are not limited to Hope Township and its residents

WHEREAS, it is professionally estimated CR 519, the only main North-South Warren County roadway will be reduced to a parking lot

WHEREAS, this CR 519 log jam will cause spill over to other roads of Warren County through the Townships of Blairstown, Allamuchy, Belvidere, Knowlton, White, Harmony, Frelinghuysen, Liberty, Independence, Hardwick, Oxford, Franklin, Greenwich, Hackettstown, Mansfield, Washington Borough & Township, Alpha, Pohatcong, Lopatcong, and Phillipsburg will become alternate routes resulting in longer commutes measured in hours not minutes.

WHEREAS, the unintended consequences will be and not limited to the following: School busing- additional time of transportation of Elementary, High School, and Vo Tech students

WHEREAS, School transportation will be directly impacted creating hardships for elementary, High School, Vo-Tech and Community College students and their parents

WHEREAS, unintended consequences will be longer response time for Fire, Rescue and Police Departments

WHEREAS, unintended consequences will be lower property values, higher taxes, higher Fire Insurance premiums, accelerated people moving out of Warren County

WHEREAS, an unintended consequence will be diminished County Commerce resulting in business closures, Job layoffs, depleted tax retables, higher taxes bills

WHEREAS, County Government was originally created for the primary purpose of providing Roads & Bridges for Commerce

WHEREAS, Commerce is the life blood of Healthy Communities, Counties, States and Country WHEREAS, a 6 million square foot Warehouse complex exceeds all known transportation capacities within Warren County

WHEREAS, a 6 million square foot warehouse will negatively affect all aspects of normal living for all Warren County residents

WHEREAS, Warren County 2018 Transportation Technical Study boldly states page 11 "Transportation and land use decision making must be grounded in a firm understanding of existing conditions and context: including the region's needs, assets, deficiencies, goals and priorities"

NOW, THEREFORE, BE IT RESOLVED that we petition all other 21 Municipalities to address the impact of the 6 million square foot Warehouse complex on their Citizens and their Towns future, and

NOW BE IT FURTHER RESOLVED, that we petition the Warren County Board of Freeholders to protect all its Citizens from the Unintended Consequences of the 6 million square foot warehouse complex, including but not limited to the alteration of our quality of life, taxes, education, police, fire, rescue squads, property values and the reasons we live here.

NOW BE IT FURTHER RESOLVED that copies of this Resolution be forwarded to Congressman Gottheimer, the Warren County Freeholders, Members of the 24th Legislative District, the 21 Municipalities of Warren County, New Jersey, the New Jersey League of Municipalities and New Jersey Conference of Mayors.

- 2. Create the Hope 2020 Calendar to promote Township Culture and events
- 3. Report to the Township Committee by December 31, 2019, identifying the Hope 250 elements that will be continued
- 4. Establish and support sub-committees to address new endeavors as necessary
- 5. Develop strategies for sustainable art and culture initiatives in municipal operations.
