# MINUTES HOPE TOWNSHIP PLANNING BOARD MEETING AUGUST 2, 2021

Chairman Larena noted the Environmental Commission Memo.

## **Approval of Minutes:**

The minutes of July 5, 2021 were distributed prior to the Board meeting. Several Board Members stated a concern that they did not hear all of the meeting due to poor internet connection. It was suggested that the Board defer the adoption of the minutes, so that the audio can be listened to.

# **Peace and Good Order Ordinance**

The Board reviewed where they left off, at the June meeting, on the discussion of the proposed ordinance. It was agreed to re-circulate the Ordinance.

## **POP Zone Discussion**

Ms. Peterson reviewed the additional language that was added in her revised memo and she stated that she supports the Environmental Commission memo.

Planner Gabel briefly described the two maps that were prepared from the State resources. The Board discussed the NC Zone, residential uses in the POP Zone, and uses. Mr. Urfer commented on the zoning of the Tramontin property and access to POP property. Mr. Maier stated his concerns over the lack of rateables and the impact to the Seniors. He stated that transportation is critical.

Mr. Koski reviewed the subcommittee's recommendation memo, which was discussed with the Board. Chairman Larena stated that he would like Elena to put some ideas together. Ms. Peterson stated that she is also interested in hearing what Planner Gabel has to say as she has experience in these issues. Ms. Gabel commented on Vehicle Electric Charging Stations as an inherently beneficial use. She also commented on gas stations/convenience stores/service stations and defining each type of use and either permitting or prohibiting that use. Ms. Gabel stated that she will compile a possible list of uses.
