#### JANUARY 28, 2020 BUSINESS MEETING

The Business Meeting of the Hope Township Committee convened at 7:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Committeeman Christopher John Kruk and Deputy Mayor Terry Urfer. Also present were Don Whitmore, DPW Foreman; Municipal Clerk, Robin Keggan, RMC; Deputy Clerk, Zondra Belstra and Brielle Walsh, Events Coordinator/Sports Director.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in The Star Gazette and The New Jersey Herald and by posting notices in the Hope Post Office and on the Township bulletin boards.

#### **Reports:**

Mayor Tim McDonough: Mayor McDonough provided an update on the progress of the tree work being done by JCP&L and subcontractors in Silver Lake. There were 150 trees cut and removed and another 12 trees that require a 10 foot boom truck will be removed in the coming days. They will be back in April (2 years ahead of schedule) to continue with tree cutting in the rest of the Township. The Township Committee went to extreme measures to ensure the BPU got this done.

There will be a meeting of the mayors of surrounding municipalities on January 29, 2020 to discuss the state of the NW Municipal Court and the surrounding municipal courts and where the future is going.

Freeholder Sarnoski has let Mayor McDonough that money has been set aside in the County budget for a traffic study on 519/521. A DOT meeting is forthcoming to discuss same with the County and New Jersey State Police.

<u>Committeeman Christopher John Kruk</u>: Mr. Kruk made note that transitioning into 2020 has been smooth. Discussed the Census meeting he attended and the importance of Hope Township residents filling out their Census papers and returning them.

<u>Deputy Mayor Urfer</u>: Mr. Urfer mentioned that the Zoning Officer has been working on the Albertson garage issue. Also that the sidewalk plans for Town Center from the County Engineer's Office are in the office and a letter will be going out to the residents that it effects so that they know they can come in and inspect the plans for themselves. The Historic Preservation Commission will be made aware of this as well.

The Food Pantry is asking for the Township's backing to help obtain a grant through the County to support farmers and the food pantry working together. Motion was made by Mr. Urfer; seconded by Mr. Kruk and all in favor.

**Brielle Walsh:** No Report.

**WHEREAS**, the Township Committee feels it necessary for electric public utilities to maintain, remove and replace dangerous vegetation to prevent future power disruptions and preserve the uninterrupted transmission and distribution of power to the residents and businesses in Hope Township.

**NOW, THEREFORE, BE IT RESOLVED** that the Hope Township Committee supports the passage of New Jersey Senate Bill S2505/Assembly Bill A2558 which concerns "Vegetation Management Response Act" and urges the legislative leadership to ensure this bill becomes law before the New Year 2020.

IN SUPPORT OF S-719/A-2426 – THE "RELIABILITY, PREPAREDNESS AND STORM RESPONSE ACT" WHICH REQUIRES PUBLIC UTILITIES TO SET BENCHMARKS FOR POWER RESTORATION DURING STORM MANAGEMENT AND STIPULATES PENALTIES FOR FAILURE TO REASONABLY COMPLY

**WHEREAS**, the Hope Township Committee finds that Superstorm Sandy, Hurricane Irene and recent snow storms and nor'easters have inflicted unprecedented damage on the citizens of the Township in recent years; and,

**WHEREAS**, weather incidents leaving residents without power for more than 5 days occurred annually for several years now; and,

**WHEREAS**, the Township of Hope relies upon well water, which means loss of power leaves residents without electricity, heat and water – circumstances that quickly become dangerous to the health and safety of residents; and,

**WHEREAS**, the Board of Public Utilities ordered the State's electric public utilities to undertake additional efforts to better prepare for any major weather event in the future; and,

**WHEREAS**, despite these additional efforts, power restoration during storms continues to focus on more populated areas leaving those rural towns such as Hope without power for days on end; and,

**WHEREAS**, legislation S-719/A-2426 calls for the "designation and prioritization of areas where a power outage may result... in loss of drinkable water due to customers' use of electric well water"; and,

**WHEREAS**, legislation S-719/A-2426 calls for the imposition of civil administrative penalties "if, after evidentiary hearings or other investigatory proceedings... the length of widespread outage was materially longer than it would have been but for the electric public utility's failure or the electric public utility's communications were materially less effective than they would have been but for the electric public utility's failure"; and,

**WHEREAS**, the legislation referenced above successfully passed the NJ State Assembly but awaits a vote in the NJ State Senate.

**NOW, THEREFORE, BE IT RESOLVED** that the Hope Township Committee supports the passage of New Jersey Senate Bill S-719/Assembly Bill A-2426 which concerns "RELIABILITY, PREPAREDNESS AND STORM RESPONSE ACT" and urges the legislative leadership to ensure this bill becomes law as soon as possible.

# RESOLUTION 2020-20 IN SUPPORT OF THE EFFORTS OF NEW JERSEY'S SUFFRAGE CENTENNIAL NJ WOMEN VOTE

**WHEREAS**, the year 2020 marks the 100<sup>th</sup> anniversary of the ratification of the 19<sup>th</sup> Amendment to the United States Constitution, guaranteeing and protecting women's right to vote; and,

**WHEREAS**, this centennial offers an opportunity to commemorate a milestone of democracy; that the right of citizens of the United States to vote shall not be denied or abridged by the Federal or State governments on account of gender; and,

**WHEREAS**, New Jersey has had a long, storied history in the suffrage movement with New Jersey women playing a crucial role in pursuing the rights of women to vote; and,

**WHEREAS**, in 1776 women property owners were enfranchised under the New Jersey State Constitution, which was unique in the nation at the time. However, in 1807, the New Jersey Legislature eliminated the property requirement for voting rights and limited the ballot to white males; and,

**WHEREAS**, in 1867 New Jersey residents Lucy Stone and Harry Blackwell organized the New Jersey Woman Suffrage Association (NJSWA), devoted to gaining women's suffrage; and,

**WHEREAS**, in 1909 New Jersey's first open air suffrage rallies were held in Orange and Newark, led by Dr. Emma O. Gantz and Martha Klatshchken with NJWSA collecting 5,000 signatures for a petition in support of the Federal amendment guaranteeing and protecting women's constitutional right to vote; and,

**WHEREAS**, although the 1912 State referendum on woman's suffrage was soundly defeated in the New Jersey Legislature, a corner was turned for New Jersey's suffrage movement; and,

**WHEREAS**, in 1913 an automobile rally led by "General" Rosalie Jones traveled through New Jersey on the way to Washington, D.C., in a Suffrage Parade of over 8,000 marchers with many New Jersey women, including event organizer Alice Paul; and,

**WHEREAS**, in 1915 a second suffrage constitutional referendum was pursued in New Jersey, New York, Pennsylvania and Massachusetts with active campaigns by many suffrage organizations, including the "Passing of the Torch of Liberty" via tug boats on the Hudson River from New York to New Jersey, but was defeated in all four states October 1915; and,

**WHEREAS**, in 1917 New Jersey suffragists Allison Turnbull Hopkins, Julia Hulburt, Beatrice Reynolds Kinkead and Minnie D. Abbott picketed in front of the White House as part of the Silent Sentinels and subsequently were arrested and imprisoned; and,

**WHEREAS**, on June 4, 1919, Congress passed the 19<sup>th</sup> Amendment guaranteeing all American women the right to vote; and,

**WHEREAS**, on February 9, 1920, New Jersey became the 29<sup>th</sup> state to ratify the 19<sup>th</sup> Amendment granting women the right to vote; and,

**WHEREAS**, shortly after the ratification of the 19<sup>th</sup> Amendment Margaret Laird and Jennie Van Ness were the first two women elected to the New Jersey Assembly in 1921 and in 1925 Rebecca Estelle Bourgeois Winston of Estell Manor was New Jersey's first woman mayor.

**NOW, THEREFORE, BE IT RESOLVED**, in honor of the 100<sup>th</sup> Anniversary of the Ratification of the 19<sup>th</sup> Amendment, Hope Township will light the municipal building in purple, one of the colors of the New Jersey Suffrage Movement, for the week of February 10; and,

**BE IT FURTHER RESOLVED** that the Township of Hope supports the efforts of New Jersey's Suffrage Centennial NJ Women Vote and strongly encourages local celebrations of this historic milestone; and,

**BE IT FURTHER RESOLVED** that a copy of this Resolution will be forwarded to the Governor, Secretary of State and New Jersey League of Municipalities.

Roll Call: Mr. Urfer – yes; Mr. Kruk – yes; Mayor McDonough – yes.

#### **Discussion:**

Mr.Urfer discussed the SADC grant for updating the Farmland Preservation Plan that the Land Conservancy has in place for the update. The cost of the SADC update is \$12,500 which is a discount off the usual rate of \$15,000 due to the long-standing relationship with the municipality. The SADC is currently matching grants at 50%, up to \$20,000, to support municipal farmland plans which means that Hope's portion will ultimately be \$6,250. On a motion made by Mr. Urfer; seconded by Mr. Kruk it was approved by the Township Committee to allow the Land Conservancy to do the update. Roll Call: Mr. Urfer – yes; Mr. Kruk – yes; Mayor McDonough- yes.

#### **Public Participation**:

Lt. Wambold was at the meeting on behalf of the New Jersey State Police – Troop B Unit. Mayor McDonough thanked him for all services the State Police provide for Hope Township. Lt. Wambold will be emphasizing patrolling our rural area roads. Mr. Urfer mentioned the problem the Township is having on the Westbound side of Route 80 before the Hope (Exit 12) Exit with trucks parking/idling there and the speeding on Route 519 south of the middle of Town. Lt.Wambold said he will make mention of these two issues to the staff at the barracks. Mr. Kruk thanked him for all of the help and assistance the State Police give the HVFD. Mr. Bodolsky (resident) inquired about putting a dedicated officer in place to monitor speeding on Route 519 south of town. Lt. Wambold stated that would entail an agreement with the Township and it is a budgetary issue for the Township would could perhaps be shared with surrounding/neighboring municipalities. This would essentially be done on an overtime basis for the trooper doing the detail.

Mr. Bodolsky spoke to the Township Committee about the potential warehouse project in White Township and urged them to take part in the meetings taking place about the project. Mr. Maier also spoke about the warehouse project. An independent traffic engineer being hired by Hope Township was also discussed by Mr. Bodolsky and Mr. Maier in conjunction with Mr. Urfer. Mrs. Rusin spoke about the traffic on CR 609 that occurred this day due to a tractor trailer accident on Route 80 causing traffic to be re-routed and the fact that it is foretelling of what could happen in Hope Township's future as it pertains to the potential rock wall on Route 80 and the potential warehouse project in White Township.

Approval of Minutes: The minutes for December 11, 2019 Business meeting; the December 11, 2019 Executive session and the December 18, 2019 year-end meeting were approved by a motion made by Mr. Urfer; seconded by Mr. Kruk and all in favor.
