The monthly business meeting of the Hope Township Committee convened at 7:00 P.M. at the Community Center, Walnut Street, Hope Township with the following members present: Mayor Timothy McDonough, Deputy Mayor Christopher John Kruk and Committeeman Terry Urfer. Also present were Municipal Clerk, Judith Fisher, RMC.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in The Star Gazette and The New Jersey Herald and by posting notices in the Hope Post Office and on the Township bulletin boards.

## **Reports:**

**Tax Collector:** for month ending June 2018 \$34,894.04; YTD \$3,095,406.04.

Warren County Health Department: 119 Nightingale – no change; 329 High Street – expansion of use beyond the approved septic capacity. Plan to alter the septic was reviewed. Additional information requested; 252 Shiloh Road – well decommissioning is pending. 32 Lakeview Avenue – complaint received re: high grass, animals and feral cats. Violation notice issued. Reinspection conducted and grass was mowed. A reinspection is scheduled. Hope Conference & Renewal Center; Inn at Millrace Pond and St. John the Baptist Facility were inspected and received satisfactory ratings. Hope Kennels inspected and received satisfactory rating; rabies – no activity. Recreational Bathing – no activity; Youth camps – no activity and campgrounds – no activity. Septics/Wells – 1 septic alteration installed; one septic repair was installed and one well/septic for new construction installed.

**Municipal Court**: Nothing new.

**Mayor Tim McDonough:** Mayor McDonough noted that Attorney Selvaggi suggested the township get a list of items available up for bid, if they don't sell then, they are free to sell to whomever. Mayor McDonough also brought State Trooper up to introduce himself. Noted to Rose Maguire (who was in audience) that she should immediately start process of applying for 501c3 so that Township can start working in tandem with her on the Foundation. Until everything in place, Township will need to co-sponsor the car show event and she should move forward. All the details will be worked out as things move forward. Mayor McDonough noted also that the Township is not subject to having to go before the Planning and Zoning Boards for permits, but Attorney Selvaggi noted as a courtesy Township should go before the Planning Board for a courtesy review to let them of the plan for the salt shed.

**Deputy Mayor Christopher John Kruk:** Ongoing issue with small animals. Someone in a neighboring municipality received a cease and desist order for raising bees. Mr. Kruk wants to nail down the animal ordinance amendments as soon as possible and get the ball rolling. Municipality owned properties need to get bid/auctioned off as soon as possible. Mayor McDonough noted attorney Selvaggi is currently working on getting paperwork together for the offering of these pieces of property. Discussion took place regarding the camp's interest in purchasing the "lake bottom" of Silver Lake which gives them a little shoreline and helps the Township to get rid of the municipal burden of it.

**Committeeman Urfer:** No updates on salt shed. Spoke about getting rid of the big generator in the yard and auctioning it off. Also spoke about the Master Plan and the expenditures for it. We are over-budget on it and need to figure out how to fund it moving forward. Mayor McDonough noted that he has told the Chairman that there is to be no more discussion about the Master Plan.

Fire Department Report: Number of calls – 13; Man hours 103. Special detail 3; Man hours 34.

**Township Engineer Report:** Absent.

Verizon Nodes: No change in status. Presentation will be upcoming from AT&T that want to do the same thing.

Benbrook & Stevens: Easement at the Distillery – Mayor McDonough stated spoke to Bob Benbrook and there is some back and forth going on between whose jurisdiction this well will be falling under (DEP). Should have a proposal in front of us soon.
