June 13, 2018

The monthly business meeting of the Hope Township Committee convened at 7:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Deputy Mayor Christopher John Kruk and Committeeman Terry Urfer. Also present were Municipal Clerk, Judith Fisher, RMC; Township Engineer, Ted Rodman, P.E.; Don Whitmore, CPWM Supervisor.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in The Star Gazette and The New Jersey Herald and by posting notices in the Hope Post Office and on the Township bulletin boards.

Reports:

Tax Collector: for month ending \$906,460.78; YTD \$3,060,512.00.

Warren County Health Department: 119 Nightingale – no change; 329 High Street – no change; 252 Shiloh Road – well decommissioning is pending. Tramontin Harley Davidson – application sent to appropriate party for unapproved temporary food. It was approved and file closed. Kennels no activity; Recreational Bathing – no activity; Youth camps – no activity and campgrounds – no activity. Septics/Wells – 1 septic alteration approved; two septic repairs were installed.

Environmental Commission: Container for plastic bags (yellow). Monica Sobon asked for the Township Committee's OK.

Judy Fisher, Township Clerk: Landscaping quotes from

Drakes Landscaping, Blairstown, NJ: \$690.00

JB Landscaping, Columbia, NJ \$815.00

K&H, Excavating, Phillipsburg, NJ: \$640.00 excluding Swayze Mill Lake.

Drakes Landscaping was the lowest quote.

Motion made by Mr. Urfer, seconded by Mr. Kruk and carried to award the mowing contract to Drake's Landscaping, Blairstown, NJ for \$690.00 for the 2018-2019 season pending a current Certificate of Insurance Roll call: Mr. Urfer – yes; Mr. Kruk – yes; Mayor McDonough – yes.

Municipal Court: Nothing new.

Mayor Tim McDonough:

Deputy Mayor Christopher John Kruk: Discussion took place regarding selling some of the municipal property (equipment). Mrs. Fisher explained how to sell on the Municipal Bid.com website that had been approved by the State.

Committeeman Urfer: Attended Gottheimer meeting and spoke about gaining approval into the website (sort of like an ebay). Must keep equipment for 18 months then can sell.

Motion made by Mr. Kruk, seconded by Mr. Urfer and carried to authorize the Mayor to sign as Director for Grant Services.

Roll call Mr. Kruk – yes; Mr. Urfer – yes; Mayor McDonough – yes.

Discussion took place regarding spraying around guardrails to control weeds. Mrs. Fisher will look into shared services with Hardwick. Planning Board didn't have copies of Master Plan, so Rose Leopardi printed them. Thank you letter should be sent to her.

Fire Department Report: 172 hours

Township Engineer Report:

Discussion took place regarding 34 Ridgeway Avenue. Conditions that were suggested to be imposed on bringing in additional fill were: permanent stabilization of the disturbed area; hours of operations (no Saturdays or Sundays); 48-hour notice to Mr. Boesze or Mr. Rodman of delivery of fill; clean off Ridgeway Avenue, no debris to be left on roadway.

Motion was made by Mr. Urfer, seconded by Mr. Kruk and carried to issue the permit based on conditions as noted above

Roll call: Mr. Urfer – yes; Mr. Kruk – yes; Mayor McDonough – yes.

Work to proceed immediately. Rodman and Boesze will monitor the implementation of conditions.

Marino – Waiver for paving entire driveway for now. Millings only, no sealing. Will be building a barn in fall so waiting on that to occur before the driveway is paved in its entirety. Mr. Marino stated he will be paving the driveway from road to house once all construction is completed (August 2019). Has a \$1,200 bond in escrow for the driveway. Asking the Township Committee to waive the requirement of have a paved apron to obtain his CO. Motion was made by Mr. Kruk, seconded by Mr. Urfer and carried to issue temporary driveway permit to waive apron paving and to be revisited June 2019.

Roll call: Mr. Kruk – yes; Mr. Urfer – yes; Mayor McDonough – yes.

Grange Generator – Site inspection/location of tank has been decided. Wires and Fairclough are working together to get generator installed and completed. Discussion took place re: trench needing to be done and who will do it (Don Whitmore v. hiring someone). Mrs. Fisher spoke about asking for the extension which would not hurt the Township.

Motion was made by Mr. Kruk, seconded by Mr. Urfer to allow Mr. Whitmore (up to 16 hours) to install trench or to approve Drakes for up to \$300 for digging the trench:

The above motion was then amended by Kruk to award the trench work to Drake's Landscaping for \$300

Salt Shed – 10' off sideline. Mr. Urfer spoke about building materials and the plan for the salt shed. He will be calling Attorney Selvaggi re: the building to make sure all is OK. Mrs. Fisher asked about a printout for expenditures to make sure we stay within the \$45,000 parameter.

Osmun Road – paperwork submitted – revised DOT drawing – need approval from DOT.

LSRP – was completed for the Cell Tower

Appointments:

Historic commission requested Frank Pervase to replace Jane Guthrie on Board due to health reasons. The Township Committee asked that he come to the next meeting so that they can meet him. Mr. Kruk suggested a letter to Ms. Guthrie thanking her for her time on the Board.

Old Business:

Verizon Nodes: No change in status

Benbrook & Stevens: Easement at the Distillery – Mayor McDonough stated spoke to Bob Benbrook and there is some back and forth going on between whose jurisdiction this well will be falling under (DEP)

New Business:

Blairstown Rotary: Annual Fireworks donation request (costs were reported to have gone up 20%). Hope Township donated \$600.

Motion was made by Mr. Urfer, seconded by Mr. Kruk to donate \$600.00 to Blairstown Rotary for the Firework Roll call: Mr. Urfer – yes; Mr. Kruk – yes; Mayor McDonough – yes.

Belvidere Heritage: Request to hang banner of CR 519 announcing Victorian Days. Mayor McDonough noted we don't have jurisdiction to approve/deny – permit needed. Mr. Kruk stated he will get further information regarding Belvidere's request.

Motion was made by Mr. Kruk, seconded by Mr. Urfer and carried that if it is past Kostenbader, Hope will allow subject to County approval.

Roll call: Mr. Urfer – yes; Mr. Kruk – yes; Mayor McDonough – yes.

Report of Audit of 2017: discussion took place regarding the report. Findings from Registered Municipal Accountant were discussed. Mr. Urfer will work with Jenny Jump land. Mr. Kruk will work with the Lake land to help alleviate tax levies. Surety bond for Tax Collector needs to be raised to \$95,542.00. Fisher already stated that this was in place already.

Motion was made by Mr. Urfer, seconded by Mr. Kruk and carried to accept the 2017 Audit Report. Roll: Mr. Urfer – yes; Mr. Kruk – yes; Mayor McDonough – yes.

Lights at Community Center: quote of \$2335.00 given to replace/update lighting. Mrs. Fisher stated she would need 2 other quotes.

4 Prospect Avenue: Member of public spoke about wanting the property. Mr. McDonough explained that the tax assessor must put a property value on it and what is owed in back taxes. Notices will go out to adjoining property owners about the property being offered for a minimum bid.

250th Anniversary 2019: Third weekend in September to combine with Hope Day was their targeted date. A general discussion took place about some of the events that they are planning to take place that day.

Brielle Walsh and Patty Whitmore: Plans for a Movie Night at Swayze Mill were discussed. Friday July 20 (Saturday July 21 rain date). Asked for the Township's blessing (may lead to 3 movies this summer).

Brielle Walsh spoke regarding the Plan B fundraiser.

Don Whitmore spoke about flying American flags in the center of town per some residents questioning as to why we don't. Don spoke about the Committee entertaining lowering speed limit on CR 519. Mr. Urfer will attend a Freeholder's meeting to discuss.

Payment of Bills:

Receipts \$8,949.65; Bills \$363,758.67. Mayor McDonough questioned the Atlantic Salt invoices due to their dates being in April. Decision was made to approve the bill pending invoice clarity being obtained about salt deliveries. SECTION II: If any selection, clause, sentence, or other part of this Ordinance shall, for any reason, be adjudged by the Court of Competent Jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

SECTION III. All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency, only.

SECTION IV. This Ordinance shall take effect and shall become operative twenty (20) days after publication thereof, after final adoption; unless within said twenty (20) days a petition signed by voters of the Township equal in number to at least five (5) percent of the registered voters of said Hope Township, protesting against the adoption of this Ordinance be presented to the Hope Township Committee, in which case the provisions of Section I of this Ordinance, which provides for increased salaries, wages or compensations of the elected officials, shall remain inoperative unless and until a proposition for the ratification of such portions of this Ordinance shall be adopted at an election by a majority of voters voting on said proposition.
