### FLAG SALUTE AND SUNSHINE STATEMENT

<u>Mayor Tim McDonough</u>: Made note that CR 611 (Hope-Great Meadows Road) construction work will being on or about April 1, 2022. In speaking with the County, they stated that they anticipate no disruption to traffic for the Land of Make Believe.

**<u>Deputy Mayor Christopher John Kruk:</u>** Spoke briefly regarding the ARP funds that the municipality is receiving and made note that if the municipality takes their monies as "lost revenues" since we are receiving under \$10 million dollars we will have more flexibility in spending it.

<u>Committeeman Urfer</u>: In support of bail coming back. Asked the Clerk to find a Resolution regarding support of bail as it pertains to the municipal courts.

<u>**DPW**</u>: Received quotes for oil and stone of Old Union Brick Road (\$6,800 - 2 coats). Also Beaver – (\$2,800 - 2 coats) and Sandy (\$3,000 - 2 coats). The Township Committee gave their approval for these roads to be done this year. Potholes are in the process of being filled. Permits for the salt shed need to be applied for.

### **RESOLUTION #2022-25**

WHEREAS, Ms. Kayleigh Keggan was hired on March 24, 2021 as the North Warren Municipal Court of hope Municipal Court Administrator; and,

WHEREAS, Ms. Kayleigh Keggan is currently considered an Interim Municipal Court Administrator pursuant to N.J.S.A. 2B:12-11(e) since she was hired March 24, 2021 and does not hold a municipal court administrator certificate; and,

WHEREAS, the statute allows the governing body to appoint a person as Municipal Court Administrator that is not a certified Municipal Court Administrator, on an interim basis, for a period not to exceed one (1) year commencing on the date of the appointment (March 24, 2021); and,

WHEREAS, the statute further states, "Any person so appointed may, in consultation with the judge of the municipal court, be reappointed as a municipal court administrator, on an interim basis, for two (2) subsequent one-year terms. The municipal court administrator appointed on an interim basis may be reappointed for a fourth, and if necessary, a fifth additional one-year term, provided the municipal court administrator is currently enrolled in the certification program and need additional time to complete that program."

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hope, Warren County, State of New Jersey, that it hereby appointed Kayleigh Keggan as Interim Municipal Court Administrator for a one-year term commencing March 24, 2022 and ending March 23, 2023.

### **Old Business:**

**Traffic Study** – Mayor McDonough spoke with Township Engineer Bill Gleba. Mr. Gleba is working on the 11-item list NJDOT submitted to Warren County. Date is forthcoming for a meeting with the DOT Commissioner.

Community Center Grant – the legal notice was run in the NJ Herald for bids to be received by architects who have been vetted and approved to do the historic work that the Community Center entails. Mr. Margulies is the person reviewing the bids. A pre-bid conference will be held on April 13, 2922 at 2 p.m. so that interested bidders may see the building and the work being requested in the bid. The bid opening is May 5, 2022 at 2 p.m. at the Hope Township Municipal Building.

### **New Business:**

Mr. Kevin Newman was in attendance to discuss the school's 2022 budget. He made note of several items regarding their budget, including the cost per child of those children who remain in Hope Township vs those who go to Ridge & Valley Charter School, etc. He also noted that no staff cuts or program cuts were made this year and, in fact, they were able to budget for a special education teacher. Their budget came in at 3% increase (5.5 cent tax levy which equates to approximately \$136 per year for the average homeowner). 130 students are enrolled in the school currently.

Mrs. Sobon discussed EV Charging Stations and presented a Power Point to the Committee on grants that are our there. Some investigation work needs to be done in order to ascertain if EV Charging stations in certain areas of Hope Township make sense and/or if the electrical lines can handle the voltage needed for them in certain areas. Ms. Sobon also updated the Committee on the Green Fair that is upcoming for April 30, 2022. Township Committee agreed to let Ms. Sobon use the Grange if need be for Green Fair activities.

Hope Preservation Commission – Mrs. Beatty was appointed on a motion made by Mr. Urfer; seconded by Mr. Kruk and all in favor. Melissa Debiak will be in attendance at our April 13, 2022 meeting to be appointed.

## **Public Participation**:

Ms. Hoffman and Ms. Shaw inquired about the status of the fill that was brought into Hope Township at 525 and 549 Hope Blairstown Road. The Committee informed her that letters were sent to several people at the DEP as well as the WC Health Department. Awaiting a response from both. It was inquired whether an LSRP could be brought in at the property owners' expense. Mr. Urfer will reach out to the Township attorney to discuss.

Minutes: Minutes for February 9, 2022 Business – motioned by Mr. Urfer; Seconded by Mayor McDonough for approval – Mr. Kruk abstained as he was absent that meeting; March 9, 2022 Business; March 9, 2022 Executive Session – motion made by Mr. Urfer; seconded by Mr. Kruk – all in favor.

Seeing there was no other business for tonight, this meeting of the Hope Township Committee was adjourned at 5:30 p.m. on a motion made by Mr. Urfer; seconded by Mr. Kruk. Motion carried.
