## MAY 10, 2017

The monthly business meeting of the Hope Township Committee convened at 7:00 P.M. at the Hope Township Municipal Building with the following members present: Mayor Timothy McDonough, Deputy Mayor George Beatty, and Committeeman Christopher John Kruk. Also present were Municipal Clerk, Judith Fisher, RMC, Township Engineer, Ted Rodman, P.E., Don Whitmore, DPW Supervisor.

Under the provisions of the "Open Public Meetings Act", adequate notice of the meeting had been provided by publishing notice in The New Jersey Herald and The Star Gazette and by posting notices in the Hope Post Office and on the Township bulletin boards.

The flag was saluted and roll call taken.

<u>Hope Township School:</u> Dawn Huff, Business Administrator and Mike Slattery, Superintendent <u>Presentation of the 2017-2018 School Budget</u>

Ms. Huff provided a handout and reviewed the budget as follows:

The 2017-20178 Budget Supports:

169 Hope Township School students Grades PK-8; 62 Belvidere High School students at \$14,400 each; 12 County Vo-Tech students at \$4,050 each; 5 Out of District Special Education Placement and 4 Charter School students.

Funding comes from the following areas:

Local Tax Levy – 72%; State Aid – 19%; Budgeted Fund Balance – cannot exceed \$250,000, any monies left over become a revenue source for the next budget or can be used for a capital expenditure; Tuition Reserves - \$75,000; Federal Grants – anticipating \$50,000 from IDEA and ASSA grants; Miscellaneous Revenue – parent pay preschool program. The school has a five-year long range facility plan in place and there will be no capital projects in this budget.

There will be no change in the local tax levy or state aid; the budgeted fund balance is up slightly. Where is funding expended:

Regular Education: 28%; Tuition BHS & Tech - 19%; Special Education K-12 - 14%; Transportation - 7%; Operations and Maintenance - 9%; Charter School - 1%; Employee Benefits - 16%; and Administration - 6%.

Ms. Huff reviewed the change in expenditures 2016-2017 vs. 2017-2018.

Committee questions were addressed throughout the presentation. Teacher contract negotiations are being conducted at this time. Declining enrollment was reviewed. Smallest class size is 12 and the largest is approximately 19.

The Committee thanked Ms. Huff and Mr. Slattery for the presentation.

## **Community Police Officer:** State Police Trooper Wojack

Trooper Wojack introduced himself to those present.

Mayor McDonough discussed the speeding issues in the township. He thanked the State Police for addressing the issue at Swayze Mill Park and noted activity will increase during the summer months. The Mayor spoke with the DOT about stop signs for the interchange paving project that have been installed without stop bars or warning signs, resulting in vehicles flying through the stop.

Mr. Beatty asked for a presence of the State Police in the township, at the park and in the town center.

#### **Engineer Report**:

**Salt Shed**: Mr. Kruk made a **motion** hiring O'Brien Associates for architectural services to prepare the salt shed drawings at a fee of \$2,570, seconded by Mr. Beatty.

**Roll Call Vote**: Mr. Kruk, yes, Mr. Beatty, yes, Mayor McDonough, yes Motion carried.

**Generator:** Specifications are currently being prepared for a generator at the DPW building, quotes to be obtained; it will not exceed \$40,000. Mr. Whitmore felt the existing propane tank would not be able to power everything during a major storm. He agreed that in order to get this process completed, the tank size could be addressed in the future.

<u>Ridgeway Avenue</u>: Kevin Cavalla has been in contact with JTG Construction. Certification is required indicating the soil leaving the site can be used as clean fill. Mr. Rodman has emailed JTG and Jack Pinto informing them they have 15 days to provide the certification, or at 30 days the township will conduct the testing and JTG will be responsible for the associated costs. If no action is taken, the Zoning Officer will issue violations.

**Status of Stormwater Management**: This item will be reported on at the May 24<sup>th</sup> work meeting. **Repairs to the Wall Historic District**: Mr. Kruk spoke with Jason Sarnoski and he was assured the grant would be awarded. Mr. Beatty felt if the County was planning on re-paving the road in front of the wall, they should include it in their grant application to the State. The County owns it and are obligated to address it. Mr. Rodman stated approximately 700 feet of wall needs to be replaced. Specifications will be needed and the Historical Board will need to approve the project as it is located in the historic district. Following further review, it was determined approximately 400 feet of wall will be replaced. Mr. Rodman will complete the grant application. Mayor McDonough will contact Mr. Trinca and Mr. Beatty will contact Tommy to obtain estimates. Mr. Kruk will contact Cory Tierney to find out the deadline for the application.

County Street Signs: Mr. Whitmore reported a complaint was received regarding road signage. He stated there are 43 township roads leading into County roads with no signs installed on them. He drove into several surrounding municipalities and the County roads are not marked. Delaware and Mt. Hermon are marked as they are two County roads coming together. The cost of a sign is approximately \$75 to \$100 each, not including those that would require special brackets. Following further discussion, it was determined a sign would be ordered for Koeck Road and Delaware, Swayze Mill and Delaware; Locust Lake and Delaware and Honey Run, based on the 9-1-1 maps. A list will be maintained and signs would be addressed as complaints are received.

#### **Payment of Bills:**

Mr. Kruk reviewed the receipts - Total: \$15,794.80

Mr. Kruk made a **motion** to pay the bills, \$762,688.46, seconded by Mr. Beatty.

Mr. Beatty stated it was discussed by the Board and he asked Mrs. Fisher to forward the information on the matter to Bob May. The owners were informed by the Zoning Officer on February 10<sup>th</sup> that they have to apply to the Zoning Board of Adjustment for approval.

## **ORDINANCE: 2<sup>nd</sup> Reading and Public Hearing**

ORDINANCE OF THE TOWNSHIP OF HOPE, COUNTY OF WARREN, STATE OF NEW JERSEY TO AMEND AND REVISE CHAPTER XXVI TITLED "EMERGENCY SERVICE VOLUNTEERS AND MILITARY PERSONNEL FEE EXEMPTION" ORDINANCE 26-1.2 TITLED "LICENSE AND PERMIT FEE EXEMPTIONS" OF THE CODE OF THE TOWNSHIP OF HOPE 2017-03

**WHEREAS**, the Committee of the Township of Hope, County of Warren, State of New Jersey, has determined that Chapter 26, "Emergency Service Volunteers and Military Personnel Fee Exemption," Ordinance 26-1.2 "License and Permit Fee Exemption" of the Code of the Township of Hope must be amended and revised to include additional exemptions.

**WHEREAS**, the Committee of the Township of Hope, County of Warren, State of New Jersey, believes that the amendment and revision of the aforesaid ordinance is in the best interests of the Township and will protect the public health, safety and welfare of its citizens.

**NOW, THEREFORE, BE IT ORDAINED** by the Committee of the Township of Hope, County of Warren, State of New Jersey that Chapter 26, "Emergency Service Volunteers and Military Personnel Fee Exemption," Ordinance 26-1.2 "License and Permit Fee Exemption" of the Code of the Township of Hope shall be amended and revised to read as follows: 26-1.2 License and Permit Fee Exemptions.

Residents who are 1) active emergency service volunteers, as confirmed by the volunteer fire or rescue squad with which they are members, and/or 2) on active duty or were honorably discharged from any of the service branches, including the Army, Navy, Air Force, Marines, Merchant Marines, Coast Guard, and National Guard, shall be exempt from the municipal fees established in the following subsections of the Code of the Township of Hope:

- 20-26.1 Zoning Permits
- 3-29 Garage Sale Permit
- 4-1.8 Peddlers, Solicitors and Transient Merchants Licenses
- 2-4.8 Fees and Deposits for Use of Community Center and Municipal Facilities

At this point, Mr. Kruk made a motion to open the meeting for comment on Ordinance 2017-03,
