Approval of Minutes:

The minutes of August 1, 2016, were distributed prior to the Board meeting. Mr. Maier made the motion to adopt the minutes. Motion seconded by Mr. Kruk. Discussion on the motion: Ms. Peterson had a question in regards to the minutes, which was addressed by Board Secretary Schemm. In a voice vote, all were in favor.
