A letter was received from Millbrook Water Association noting that they held their meeting in September and voted unanimously that effective October 31, 2016 that water will no longer be supplied to anyone other than Millbrook Water Association members. Presently water is being supplied to the Community Center from this Association. The Committee discussed various options of how to provide water to the Community Center. Since the Township now owns the home across from the Center, they discussed getting the power turned on to see if the well is working. If it is, this could be useful in supplying water to the Center. Mayor McDonough did note that there are several items that need to be cleared by Township Attorney before anyone goes into this house. The Clerk will work with the Construction Official on getting the necessary paperwork started to get the power turned on order to check the well pump. Update at the next meeting.

JCP&L have been in the area trimming trees from the Silver Lake area to the Blairstown sub-station.

<u>Deputy Mayor Beatty:</u> Permission was given to the Taylor's to install the bench at Swayze Mill Park. The Environmental Commission liked the bench and pad that was done.
