ORDINANCE NO. 14-04

AN ORDINANCE OF THE TOWNSHIP OF HOPE, COUNTY OF WARREN, STATE OF NEW JERSEY, TO AMEND, REVISE AND REPLACE SECTION 7-26 OF THE HOPE TOWNSHIP CODE TO REVISE THE SPEED LIMIT FOR RIDGEWAY AVENUE

WHEREAS, the Mayor and Committee have determined that the present speed limit on Ridgeway Avenue located in Hope Township is excessive and presents a danger to the public; and

WHEREAS, the Engineer has provided a certification under his seal as a licensed professional engineer pursuant to N.J.S.A. 38:4-98 et seq.; and

WHEREAS, the Township Committee of the Township of Hope, County of Warren, State of New Jersey, desires to amend, revise and replace Section 7-26 of the code of the Township of Hope to reduce the speed limit on entire length of Ridgeway Avenue to 25 mph; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hope, County of Warren, State of New Jersey, that the Hope Township Development Regulations Ordinance is hereby amended to delete Section 7-26 and replace it with the following:

7-26 SPEED LIMITS.

The following speed limits shall be established on the following streets or parts of streets:

Section 2:

<u>Severability.</u> The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 3. Repealer.

Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 4. Effective Date.

This Ordinance shall take effect upon final passage and publication.

A RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SERVICES FROM KENNETH KRAUSE, ESQ.

WHEREAS, the Township of Hope has a need to acquire professional services from Kenneth Krause, Esq. with offices at P.O. Box 366 (329 High Street), Hope, NJ 07844 as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the Township of Hope has determined and certified in writing that the value of the acquisition will not exceed \$13,000.00 for general legal services; and

WHEREAS, the anticipated term of this contract is twelve (12) months; and

WHEREAS, Kenneth Krause, Esq. has submitted a proposal dated January 1, 2014 indicating he will provide the professional services for the amount of \$300.00 per court appearance; and

WHEREAS, Kenneth Krause, Esq. has completed and submitted a Business Entity Disclosure Certification which certifies that Kenneth Krause, Esq. has not made any reportable contributions to a political or candidate committee in the Township of Hope in the previous one year, and that the contract will prohibit Kenneth Krause, Esq. from making any reportable contributions through the term of the contract; and

WHEREAS, the Chief Financial Officer of the Township of Hope has provided certification of the availability of funds in accordance with N.J.A.C. 5:30-5.4.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Hope authorizes the Mayor, Timothy C. McDonough to enter into a contract with Kenneth Krause, Esq. as described herein; and

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution;

BE IT FURTHER RESOLVED that Kenneth Krause, Esq. agrees to incorporate into this contract the mandatory language of subsection 3.4(a) of the Regulations promulgated by the Treasurer pursuant to P.L. 1975, c. 127, as amended and supplemented from time to time and the contractor or subcontractor agrees to comply with the terms, provisions and obligations of said subsection 3.4 (a) provided that said subsection shall be applied subject to the terms of subsection 3.4 (d) of said Regulations; and

WHEREAS, the parties to this contract agree to incorporate into this contract the mandatory language of section 5.3 of the Regulations promulgated by the Treasurer pursuant to P.L. 1975, c. 127 as

amended and supplemented from time to time and the contractor or subcontractor agrees to comply with the terms, provisions and obligations of said section 5.3.

BE IT FURTHER RESOLVED that the Municipal Clerk is directed to publish notice of this action in the legal section of The Star Gazette.

RESOLUTION GRANTING APPROVAL OF THE PURCHASE OF A DEVELOPMENT EASEMENT ON THE BEAVER BROOK FARM BLOCK 3200 LOT 300 IN HOPE TOWNSHIP AND BLOCK 701 LOTS 1 & 1.03 IN FRELINHUYSEN TOWNSHIP CONSISTING OF APPROXIMATELY 140.92 ACRES

WHEREAS, the Warren County Agriculture Development Board (WCADB) has determined that the property known as the Beaver Brook Farm, owned by The Land Conservancy of New Jersey located on Block 3400 Lots 400 & 1400 and Block 3401 Lot 400 in Hope Township, consisting of approximately 140.92 acres, has available for purchase a development easement in accordance with the requirements of the farmland preservation program; and

WHEREAS, pursuant to <u>N.J.A.C.</u> 2:76-17.9A(b) on October 4, 2013 it was determined by the State Agriculture Development Committee (SADC) that the application for the sale of a development easement was complete and accurate and satisfied the criteria contained in <u>N.J.A.C.</u> 2:76-17A.9(a); and

WHEREAS, pursuant to <u>N.J.A.C.</u> 2:76-17A.11, on January 23, 2014 the State Agricultural Development Committee has certified a development easement value of \$3,979 per acre based on zoning and environmental regulations in place as of 1/1/04 and \$3,979 per acre based on zoning and environmental regulations in place as of the current valuation date of November 27, 2013 with an estimated total value of \$560,720.68; and

WHEREAS, the property is part of the approved Warren County Planning Incentive Grant application and is funded by the Warren County Open Space, Farmland, Recreation and Historic Preservation Trust Fund; and

WHEREAS, the tract would encourage the survivability of production agriculture in Hope Township, and said tract falls within a predetermined County Agricultural Development Area and is in the North West Project Area and property is located in the Highlands Planning Area; and

WHEREAS, the purchase of the development easement on the property will encourage the survivability of the productive agriculture in Hope and Township and Warren County; and

WHEREAS, the pressures from development have significantly heightened the degree of imminence of change of land use from productive agriculture to non-agriculture uses; and

WHEREAS, preliminary approval for the purchase of development rights on this farm has been granted by the State Agricultural Development Committee; and

WHEREAS, the SADC is expected to grant final approval for funding amount on said application at its March 27, 2014 meeting; and

WHEREAS, pursuant to <u>N.J.A.C.</u> 2:76-17.13 on February 20, 2014, the Warren County Agriculture Development Board is expected to approve the funding for the development easement with estimated cost share with no cost share contribution by Hope Township as follows: SADC \$392,800.41, Warren County \$167,920.27; and

WHEREAS, the WCADB approval will include the following conditions:

- a. No existing dwellings or structures on premises
- b. No existing agriculture labor housing on premises
- c. Two exception areas
 - 1) One non-severable exception of .65 acre for conversion of existing barn to single family residence restricted to one residential unit
 - 2) One non-severable exception of 1 acre for future single family residence restricted to one residential unit
- e. No Residual Dwelling Site Opportunities (RDSO's)
- f. No preexisting non-agricultural uses on premises
- g. Access easements to be determined by title search
- h. No proposed trails
- i. Warren County is requesting SADC funding for a 3% buffer on the final surveyed acreage

NOW THEREFORE BE IT RESOLVED, by the Township Committee of Hope as follows:

The Township Committee of Hope hereby grants permission for the purchase of the development easement by the County of Warren under the Farmland Preservation Act as set forth above and will not be participating in cost share.

RESOLUTION REQUESTING APPROVAL OF THE DIRECTOR OF THE DIVISION OF LOCAL GOVERNMENT SERVICES TO REVISE THE TITLE OF THE "HOPE TOWNSHIP ANNUAL CHRISTMAS CRAFT MARKET" DEDICATED TRUST BY RIDER, WHICH WAS ESTABLISHED PURSUANT TO N.J.S.A. 40A:50-29

WHEREAS, the Township Committee of the Township of Hope in the County of Warren, New Jersey, established via Resolution #2009-25 on April 8, 2009 the "Hope Township Annual Christmas Craft Market" Dedicated Trust by Rider; and

WHEREAS, the municipality conducts the Annual Christmas Craft Market and other cultural events for residents for which the Township of Hope receives revenues that are not subject to reasonable accurate estimates in advance; and

WHEREAS, N.J.S.A. 40A:50-29 allows municipalities to receive amounts for costs incurred for "Celebration of Public Events"; and

WHEREAS, N.J.S.A. 40A:4-39 provides that the Director of the Division of Local Government Services may approve expenditures of monies by Dedication by Rider;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hope in the County of Warren, New Jersey as follows:

- 1. The Mayor and Township Committee hereby request permission of the Director of the Division of Local Government Services to authorize that the title, "Hope Township Annual Christmas Craft Market Dedication Trust by Rider" be revised to "Hope Township Celebration of Public Events Dedication Trust by Rider";
- 2. The Mayor and Township Committee hereby request permission of the Director of the Division of Local Government Services to pay expenditures for the "Hope Township Celebration of Public Events Dedication Trust by Rider" as per N.J.S.A. 40A: 4-39.
- 3. The Municipal Clerk of the Township of Hope is hereby directed to forward two certified copies of this Resolution to the Director of the Division of Local Government Services.
