Approval of Minutes:

The minutes of January 23, 2012, were distributed prior to the Board meeting. Chairman Fish noted a correction.

Mr. May made the motion to adopt the minutes. Motion seconded by Mr. Maier. In a voice vote, all were in favor, except for Mr. Koonz, Mr. Larena, and Mr. Rosenberg, who were not present at the January meeting and they abstained.

Open to the Public:
