 - Please note these are simply my notes from the discussion, not the final, approved statements. As such, conditions' discussion touched on during the evening included:
 - plans will be revised to show the diesel pump being moved from the back of the left lot to the canopied row, with propane tanks remaining where they are currently located; the diesel pump will be not be high-speed flow;
 - restroom facilities will be renovated/located in the building and the porta-potties and outhouse will be removed;
 - there will be a privacy fence between the Gas Station and Barber Shop;
 - the 300' buffer for the C1 Brookaloo Creek would be noted;
 - to improve stormwater run-off filtration, the area west of the well to the fence will no longer be mowed;
 - there will be attention towards keeping new lighting aimed downward to minimize light pollution and the current lights on the building may also be modified to be more dark-sky friendly;
 - there will be 2 signs indicating "No Tractor Trailer Entry or Parking";
 - the new tanks will be double-walled; installation and testing samples will be DEP-compliant
 - tanks will be electronically monitored; in the event of a leak, the alarm will sound for the operation to be shut down
 - there will be a no-idling sign
